The following is the 2024 Fee Schedule for the Purgatory Metropolitan District. The District Board would like to remind users that there is an annual 4% increase to the service fee as approved with the 2019 rate study, this increase will take effect May 1<sup>st</sup>. in Addition there is a 3% increase to Park/Recreation and Road fee that is required by the DMR Land Use Regulations. Please refer to the District's Codes and Standards for the applicability of these Fees to individual projects, and the timing of payment. All fees should be remitted to the Purgatory Metropolitan District, P.O. Box 2501, Durango, Colorado, 81302 or can be dropped off at the District's offices located at 49786 HWY 550N Durango, Colorado 81301.

Fee amounts are subject to change, please contact the District Manager at (970) 799-6383 prior to paying any fees to confirm current amounts. Unless otherwise noted, all fees are on a per unit basis for properties that are within District boundaries. All fees and charges for any facilities or property requesting service outside the District boundaries are considered on a case by case basis.
